

HUNTING RULES

GEMSBOKFONTEIN, VLAKFONTEIN, AND GLENTIG

1. Nobody may or shall handle a firearm on the premises without permission of the owners or their duly authorised representative in the presence of a approved professional hunter and or guide.
2. In the presence of other people a firearm may only be loaded on a vehicle when aiming at an animal and not prior to this. The firearm shall be unloaded immediately after the shot has been fired or after the hunter has decided not to discharge the firearm.
3. All arms and ammunition shall be locked away in the safe before and after each hunt.
4. The hunter shall accept sole responsibility for the personal safety and conduct of any non-hunter who accompanies him/her and such person shall be under the authority of the Professional Hunter and may be banned from the hunt in case of misconduct.
5. Any hunter or spectator who contravenes any law pertaining to hunting shall do so at his/her own risk.
6. All persons entering the premises shall do so at their own risk.
7. **THE USE OF ALCOHOL BEFORE OR DURING THE HUNT IS PROHIBITED.**
8. **UNDER NO CIRCUMSTANCES MAY ANY INTOXICATING LIQUOR BE GIVEN TO GUIDES OR EMPLOYEES.**
9. The onus of deciding whether to fire a shot shall rest upon the hunter, who must ensure that the animal shot on the premises, is correctly identified. If a hunter causes any damage to movable or immovable property or trees or plants through reckless or unnecessary shooting, the hunter will be fully liable for any damage thereto.
10. **Wounding and missed shots:**
 - a. Wounding shots shall be counted as if the animal concerned was hunted and found at the sole discretion of the guide.
 - b. The Professional Hunter shall have the right to shoot any wounded game.
 - c. **The hunter will pay a premium of R114-00 for every shot that is fired at an animal and missed, irrespective if the animal is wounded or not.**
11. Gratuities for good service are welcomed after the hunt, but any **bribes** to employees to keep silent about missing or wounding shots shall be handed to the owner who will double the amount and fine the briber 10 times such amount.
12. Fires may only be lit at places specifically specified for this purpose.
13. Hunters hereby acknowledge that they are fully aware of all the costs applicable and that they are able to pay such cost on demand.
14. Any claims or complaints, which might arise, shall be lodged in writing before leaving the premises, otherwise the owner will disclaim any responsibility.
